

Fuji Impulse Warranty Policy

One Year Warranty from the date of purchase within North America:

Fuji's goal is to provide the best, most reliable service and conscientious support possible. Fuji will, at its option, repair or replace, for the original purchaser, at no charge, any part or parts found to be defective in material or workmanship, provided you return it (postage/freight prepaid, with proof of your purchase from the original reseller) during the 12-month period after the date of your original purchase of the product. This warranty covers unit, which has been operated and maintained in accordance with the operating manual and instructions furnished with the unit, and which has not been subject to misuse, abuse, neglect, accident, improper maintenance or alteration. All normal wear part failures will be covered on Fuji product for a period of 30 days. After 30 days, but within the one-year period, normal parts failures will be covered ONLY if caused by defects in material or workmanship of OTHER component parts. Normal wear parts are defined as Heating Element, Silicone Rubber, Teflon Sheet, Glass Tape and Sarcon Sheet. In order to qualify, user needs to apply "Online User Registration". Fuji Warranty service is available, with proof of purchase and information of (1) the product serial number, (2) part number affixed to the unit, (3) Your (Contact) Name, (4) Your Company Name, (5) Contact Details – facility address, telephone number and email address, through Fuji or its local distributors. Warranty does not cover routine maintenance items nor cover normal deterioration of the exterior finish due to use or exposure.

This is our only warranty and your exclusive remedy concerning the product, all other representations, warranties or conditions, express or implied, written or oral, including any warranty of merchantability, fitness for a particular purpose or non-infringement, are expressly excluded. As a result, except as set out above, the product is sold "as is" and you are assuming the entire risk as to the product's suitability to your needs, its quality and its performance. In no event will the manufacturer be liable for direct, indirect, special, incidental or consequential damages resulting from any defect in the product or from its use, even if advised of the possibility of such damages. All exclusions and limitations of this warranty are made only to the extent permitted by applicable law and shall be of no effect to the extent in conflict with the express requirements of applicable law.
